Sadly, there was a disappointing end to the season in division 3 as the last but one match between Standard A and Potters Green was cancelled. This was due to one of the Potters Green players

In division 4 Attleboro B were awarded 4 walkovers in their Saturday fixture v Standard B, Midweek div 4 Alvis B were awarded 3 walkovers v Albany B and on 21st September Old Coventrians conceded 3 walk overs at home to Stoke Coventry B.
