4. Secretary's report

At our back to bowls meeting, we took a moment to acknowledge the bowlers we have lost over the time we have had apart and to all who have suffered a loss of loved ones, we send each and every one our loves and best wishes.

I can confirm that Baddesley will no longer be bowling on a Monday night. Unfortunately, Weddington Social will not be entering a team. We have Windmill and SAA reducing to one team but on a positive note we have new teams with the Wagon, Dunlop Thunder and Dunlop Lightening. Also please note that Coventry Colliery are now to be known as Kersley Colliery. BBC has been lost as a green completely and for North Midlands League Weddington is now longer being used as Weddington Social have withdrawn and Weddington Diamonds are now Griff Diamonds. 9. Notices of Motion/Rules

Rule 21 has not been noted as an official Rule change however the committee would like to remind you that vaping, and use of smart watches should not be encouraged on the green to ensure we remain within our social etiquette of the game.

Rule 25 No player shall play in more than one team or league on a Monday. This rule is not expanded but the committee would like to reword to ensure they understand that by one team it is meant one affiliated club, players are able to swap between teams within their club but not during that last 4 games of the season where promotion/relegation is likely.

Proposed by Haunchwood Club

We wish to propose that part of Rule 11 is changed from " All League matches during April and September to commence at 6.00 pm (1800). All other matches to commence at 6.30 pm unless mutually agreed otherwise by both captains. Visiting teams shall be allowed 15 minutes for practice and exclusive use of the green for this purpose finishing five minutes before the time fixed to start the match. Final time for a player to play a League game to be 45 minutes from the scheduled start."

To: "All League matches during April and September to commence at 6.00 pm (1800). All other matches to commence at 6.30 pm unless mutually agreed otherwise by both captains. Visiting teams shall be allowed 15 minutes for practice and exclusive use of the green for this purpose finishing five minutes before the time fixed to start the match. Final time for a player to play a League game to be **1 hour** from the scheduled start."

The reason for this proposal is that many teams are have ladies who work and the start times can be a problem – however giving more time to arrive will be beneficial.

This motion was voted on and the motion was not carried as the vote was 20 - 22.

Proposed by Haunchwood Club and Attleborough Sports Club

We wish to propose that **Rule 9** is changed from: All matches controlled by the League shall be governed by the Laws of Crown Green Bowls as set forth by the British Crown Green Bowling Association. In League matches each club shall be represented by **seven** players, games to be 21 up singles, home and away matches must be played, one point awarded for each individual games won plus 2 points for home win and 3 points for an away win. In the event of a draw on shots, the home team shall receive one point, the away team two points.

Propose change to 6 players

This motion was voted on and the motion was not carried as the vote was 6 - 22.

Proposed by Newdigate Club

Propose change to 8 players as the league was originally formed.

This motion was voted on and the motion was not carried as the vote was 6 - 22.
